Apart from the executive committee, ULPHAT is always graced by impassioned medical and non-medical volunteers. These volunteers contribute in various course of actions; which include assisting patients, channelizing treatment, coordinating information and also collecting funds.

HIGHLIGHTS FOR 2014

ULPHAT joined hands with Pakistan Navy in conducting medical camps in the coastal areas of Sindh and Baluchistan. 10 medical camps were held this year which catered 10992 patients collectively. These camps were held in areas such as Bhit Island, Mubarak Village, Baba Island, Daamb port Sonmiani, district Lasbella and Chuhar Jamali. A record number of 1755 patients were accommodated in the camp at Chuhar Jamali.

In the medical camp at Mubarak village, night blindness issue was found to be a common condition for which WHO (Surveillance Officer Disease Early Warning System (DEWS)Karachi) and district health department of Mubarak village area were notified and they then took charge and the children were able to received vitamin A along with vaccinations.

Donations were also collected this year for—Thar dought relief and the amount was used on relief goods such as tents, medicines, family ration packs, Dari etc. This Project Thar was initiated this year with the intent of helping our fellow citizens who are deprived of healthcare services and basic facilities of life. A central base camp at Mithi was established and the donations were handed over to Pak Navy.

ULPHAT received its media coverage this year and was introduced nationwide on ARY channel on 21st July 2014. It was invited by ARY on Ramadan Faizan with Junaid Jamshaid. A very positive response was received and a lot of children were referred for treatment.

An Iftar party was organized at an orphanage, Al Mohsin Hall in Gulberg – Karachi. It was hosted by the platform of ULPHAT This year we also started a joint venture with Smile Train to treat patients with cleft lip and palate.

Over the year, 71 children received individual treatment for complicated issues such as Severe Pulmonary Valve Stenosis, cleft lip and palate, Ventricular Septal Defect, Atrial Septal Defect, Tetralogy of Fallot etc. Our youngest star was Manala. She had congenital pulmonary valve stenosis and underwent atrial septostomy and baloon pulmonary valvostomy on her second day of life. Ulphat is very thankful to committed doctors like Dr Asif Hassan who travelled all the way from UK to operate on these very complex heart conditions.

ULPHAT WELFARE ORGANIZATION NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED JUNE 30, 2014

1 NATURE OF OPERATION

The society was registered as Ulphat Welfare Organization on May 25, 2010 under the voluntary Social Welfare Agencies (Registeration and Control) Ordinance 1961. The registered office of the society is A-159, Block N, North Nazimabad, Karachi. The society is engaged for helping needy persons, specially children who require urgent surgery and can not afford quality intervention and post operative care. Ulphat also provide ration to the needy during Ramzan and other times in a year.

2 SIGNIFICANT ACCOUNTING POLICIES

2.1 Statement Of Compliance

These financial statements have been prepared in accordance with the requirements of International Accounting Standards.

2.2 Accounting Convention

These financial statements have been prepared under the historical cost convention.

2.3 Cash & Cash Equivalent

Cash and cash equivalents are carried at cost. For the purpose of the cash flow statement, cash and cash equivalents comprise of cash in hand and deposits held with banks.

2.4 Revenue

Donations received are presented at the time of receipt i.e. when received as cash or deposited in the bank account.

Donations restricted in its use, are utilised for the specified purpose and are classified as donations under restricted fund account. Any income made from such restricted donations is also credited directly in the restricted fund account

2.5 Expenses

All expenses are recognised in the income and expenditure account on accrual basis. Expenses incurred out of donation are reflected in the income and expenditure account, with an equal amount being recognised as "Value of services rendered".


